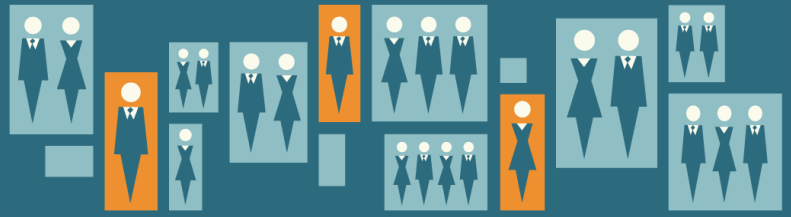


# EXHIBITOR CONTRACT
